## 2009 DAVE C. RACE RELEASE FORM

I acknowledge that participating in ski racing involves a RISK OF PERSONAL INJURY to me or my child and damage to my property, and I knowingly and voluntarily agree to the terms and conditions outlined in this Waiver and Release of Liability. In exchange for being permitted to participate, I agree to the following:

I (participant) am in good health and have no physical conditions that affect my ability to participate in Ski Racing and have not been advised otherwise by a medical practitioner.

I ASSUME ALL RISKS associated with my involvement with Ski Racing and the risk of injury caused by the condition of any property, facilities, or equipment used during the Ski Racing, which may not be reasonably foreseeable by anyone at any time. I agree not to sue Learn to Ski, Inc., Pine Knob Ski School and Pine Knob Ski Area, affiliates, and their successors, assigns ("Companies"), their respective employees, agents, or other volunteers, and insurers of any of the above for any injuries, losses, damages, claims, liabilities, or expenses that are caused or alleged to be caused by their negligent or reckless acts or omissions, hazards that are normally associated with participating in Ski Racing, or the condition of the property, facilities, or equipment used for Ski Racing.

I agree to indemnify, defend, and hold harmless Companies and their employees, agents, volunteers, and insurers of any of the above from and against any claims, causes of action, damages, judgments, liabilities, fees (including attorney's fees), costs, and expenses incurred by Companies as a result of my unlawful actions or failure to act during Ski Racing.

I agree to wear appropriate safety equipment as established by common safety practices during all activities with regard to Ski Racing. In connection with any injury or other medical conditions I may experience during Ski Racing, I hereby consent to receive medical treatment deemed necessary by medical personnel if I am not able to act on my own behalf. I agree not to sue any applicable medical practitioners who may provide medical treatment to me for malpractice.

This Waiver is a legally binding agreement and will be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. Any provisions found to be void or unenforceable shall be severed from this agreement, and not affect the validity or enforceability of any other provisions.
